DECLARE TO BE INFORMED OF, ACKNOWLEDGE AND AGREE THAT

1. PEAKSHUNTER.COM and its Mountain Guides will do everything possible, thanks to their experience and professionalism, to ensure the participants' utmost safety. However, mountain sports activities are potentially dangerous to personal safety and exposed to objective risks due to environmental characteristics and weather conditions (e.g. falling rocks, avalanches, crevasses, sudden weather changes, etc.);
2. Participants must be duly trained, both physically and mentally, to perform the activities they want to take part in organised by PEAKSHUNTER.COM. To this end, they must inform PEAKSHUNTER.COM and its Guides about their technical skills, previous experiences, physical condition, and any health problem of whatever nature;
3. given the objective and/or subjective conditions and situations that may occur in every instance, PEAKSHUNTER.COM cannot guarantee the full execution of the scheduled activity (e.g. for mountaineering, reaching the summit); Mountain Guides can, at their sole discretion, cancel or change, in whole or in part, the schedule according to the environmental and weather conditions and the physical and/or mental conditions of each participant.
4. PEAKSHUNTER.COM and its Mountain Guides will not be held liable for any injury to people and/or loss of or damage to their belongings during the activities, without prejudice to the limits established by law;

UNDERTAKE TO

5. inform the Mountain Guide about my technical skills, experiences, and my physical condition, deeming myself fit for PEAKSHUNTER.COM's activity; I acknowledge that PEAKSHUNTER.COM will not be held liable in the event of omissions and/or untruthful statements;
6. abide by the instructions provided by the Mountain Guide during the activity, including those regarding the equipment, clothing, and specific technical skills required for the scheduled activity.

ALSO DECLARE

7. to be well-informed about the activity I want to take part in, its characteristics and its relative schedule, as well as about the equipment, clothing, and specific technical skills required;
8. to have been informed, in particular, about the risk of avalanches on the day of the activity and the risk of falling in crevasses in the event of activities carried out, in whole or in part, on glaciers;
9. to have viewed and to accept the terms and conditions and fees applied by PEAKSHUNTER.COM to the chosen activity;
10. to release PEAKSHUNTER.COM (including its directors, managers, employees, collaborators, consultants, etc.) and Mountain Guides, who have provided their professional service during the chosen activity, from any and all liability for any injury and/or damage to property that I may suffer during my participation in these activities, notwithstanding the limits established by law;
11. to commit to indemnify and hold harmless PEAKSHUNTER.COM (including its directors, collaborators, consultants, etc.) and the Mountain Guides from any and all liability, including any legal costs, for claims, losses, or injuries suffered by third parties and/or property due to my conduct;
12. that the images taken and audio recorded during my participation in PEAKSHUNTER.COM's activities with any video or audio equipment will not be used for purposes other than private and domestic use;
